- A Macintosh with USB support
- Mac OS 8.6 to 9.x or OS 10.1 or higher

Windows PC Users:

- A Windows PC with USB support
- Windows 98, Windows 98 SE, Windows Me, Windows 2000, or Windows XP

Introduction

Most users only need to connect the SmartDisk Floppy Drive to their computer's USB port to begin storing and transferring files. However, if you are a Mac OS 8.6, Mac OS 10.0.x , Windows 98 or Windows 98 SE user, please follow the special instructions described under the relevant heading in this Chapter.

Power Requirements

The SmartDisk Floppy Drive gets its power from the USB connection, so no additional power is required. This is the case if the SmartDisk Floppy Drive is connected to your computer's internal USB port or to a powered USB hub. However, the SmartDisk Floppy Drive will not work if it is connected to an unpowered USB hub such as the Apple keyboard.

Macintosh Users

Most Macintosh Users can simply plug in the SmartDisk Floppy Drive to use it as described below. However, the following OS versions need extra support.

- **OS 8.6 Users:** Please install "USB Mass Storage Support" version 1.3.5 or newer, available from Apple at: <http://www.info.apple.com/support/downloads.html>
- **OS 10.0.x Users:** Please upgrade to OS 10.1 or higher in order to use a floppy disk drive.



Caution

Do not force the connection as damage may occur to the connector or the USB port.

To connect and use the SmartDisk Floppy Drive:

- 1 Plug the SmartDisk Floppy Drive USB cable into the USB port on your computer or powered USB hub.
- 2 Insert a formatted floppy diskette into the floppy drive. A floppy icon appears on your Macintosh desktop.

Congratulations! You can now use your SmartDisk Floppy Drive to store files.

Windows Users

Windows Me, Windows 2000 and Windows XP (Home and Professional users) simply need to connect the SmartDisk Floppy Drive to begin using it as described below. Windows 98 and Windows 98 SE users must follow the instructions in “For Windows 98 / Windows 98 SE Users Only” to begin using the SmartDisk Floppy Drive (see below).

Do not force the connection as damage may occur to the connector or the USB port.

To connect and use your SmartDisk Floppy Drive:

Plug the SmartDisk Floppy Drive USB cable into the USB port on your computer.

The SmartDisk Floppy Drive icon appears in *My Computer* and in *Windows Explorer*. Congratulations! You are now ready to use your SmartDisk Floppy Drive.

For Windows 98 / Windows 98 SE Users Only:

- 1** Plug the SmartDisk Floppy Drive USB cable into the USB port on your computer. The *Add New Hardware Wizard* appears. Click **Next**.
- 2** Choose “Search for the best drivers for your device”. Click **Next**.
- 3** Select “CD-ROM” and clear all other check boxes.
- 4** Insert the SmartDisk Floppy Drive Installation CD into the CD-ROM drive.
- 5** Click **Next**.
- 6** The *Add New Hardware Wizard* notifies you that it is ready to install. Click **Next**.
- 7** After the *Add New Hardware Wizard* notifies you that it has finished installing, click **Finish**.

The SmartDisk Floppy Drive drive letter is now visible in *My Computer* and in *Windows Explorer*. Congratulations! You are now ready to use your SmartDisk Floppy Drive.

Introduction

Your SmartDisk Floppy Drive works the same as any other floppy disk drive. The only exception is that you cannot start your computer from a bootable floppy disk using the SmartDisk Floppy Drive.

Supported Disk Formats

The SmartDisk Floppy Drive reads and writes to the following high density disks:

- 1.44 MB disks (both PC and Mac format)
- 1.25 MB disks
- 720 KB PC formatted disks.

Please note that low density (400 KB and 800 KB) formatted disks are not supported.
